This offer is available to all growers who purchase and apply Utrisha N to their wheat, barley or canola crop between the **1st April** and **31st August 2025**.

Terms and Conditions

To be eligible for participation, your application must meet the following conditions:

- Purchase a minimum of 100kg of Utrisha N from any certified agent between **1st April** and **31st August 2025.**
- Register by **30th September 2025**. Proof of purchase must be uploaded when registering.
- Apply Utrisha N in accordance with the label and ensuring that you consult the latest compatibility information. For the latest compatibility chart visit <u>utrishan.compatibility.corteva.com.au</u>
- If eligible pursuant to this programme, Corteva Agriscience will provide a refund of the purchase amount of Utrisha N only. Application costs and any tank mix partners are excluded from this offer.
- Utrisha N performance will be assessed on a field-by-field basis. Each field should have two untreated strips at least three header fronts wide that are representative of the paddock and have been managed in an identical fashion to the Utrisha N treated area. Where fields larger than 100 ha are registered there should be one untreated strip per 50ha of field. i.e. <100ha (2 strips), 100-150ha (3 strips) etc. Representative should be interpreted as not on a low/high area, old fence line, tree line or where the yield would be impacted in a way that is different to the rest of the field.
- If adverse weather or a frost event causes a Utrisha N treated wheat or barley crop to yield less than 1T/ha, or canola to yield less that 750kg/ha Corteva will provide a refund on the purchase amount of Utrisha N, unless these crops have been cut for hay or silage.
- In the event of a claim yield data will only be accepted in electronic form from GPS yield monitoring systems (see "How to Claim" for further details), you must ensure that these capabilities are available.
- All claims must be submitted by 31st January 2026
- Claims assessment will be completed and applicants notified by 31st March 2026

Step 1:

- Register for the offer before **30th September 2025**
- Upload proof of purchase

• If you wish to make a claim or share your story, submit via the link in your registration email by **31st January 2026** with the required information.

Required Data for Submission - Yield Data & Field Activity Records

Yield Data:

The following information must be provided electronically as data files.

- Treated paddock shape file (not an output map)
- Treated and untreated area shape file (not an output map)
- Yield data file (not an output map) consult this link to see if you are able to supply the
 appropriate data file (Click <u>here</u> to access to the link)
- Hand-drawn maps, weighbridge tickets etc will not be accepted.
- Please ensure you can supply the required data in the correct format before committing to the Utrisha N program.

Field records:

This information can be provided as a download .pdf from your field management system or entered manually into the claim. The field records required in the event of a claim will include the following details.

- Crop type, variety, sowing date and rate.
- Fertiliser program for the crop year. Including application dates, rates and product details.
- All herbicide, insecticide and fungicide treatments date, water rate and weather conditions.
- Utrisha N treatment details crop stage at application, date, water rate, tank mix partners, weather conditions.
- Seasonal weather records rainfall and temperature.
